Report from Governing Council

The OHHK staff, Parent Voice members, had a very busy and successful year in 2023. The children left kindy as capable, resilient, and school ready graduates that developed wonderful relationships with their peers and educators. In 2023, the children explored, imagined, played, created, and shared in an engaging program, supporting their needs.

Literacy was well explored with educators supporting book making and encouraging the children to become authors and illustrators and presenting them to the class, developing their early literacy skills.

The children also enjoyed the outdoor play spaces, from climbing trees, collecting bugs and being curators of their vegetable garden. Musical Muscles was once again enjoyed with Caleb, where they developed confidence and became enthusiastic musicians which was demonstrated to parents in Term 2.

The Parent Voice continued to fundraise for equipment purchases. It included framed art created by the children, a wine drive, individual artwork on a variety of homewares and the obstacle-a-thon. The total amount raised this year was \$2502.47. The obstacle-a-thon saw the children thriving in their play space. They were able to welcome parents into the kindy and demonstrate their amazing gross motor skills.

A successful community is vital in the education of every child and I would like to acknowledge the time and effort parents put into making our kindy a safe and inviting environment. I acknowledge the work of Parent Voice members who engaged in discussion and decision making regarding the kindy going forward. I also acknowledge the work of the OHHK team, who continue to provide a quality and engaging program where the children thrived and became competent and independent learners.

In South Australia, preschool attendance is not compulsory, but it is strongly encouraged. Preschool gives children the best opportunity to develop skills, which prepare them for school. These benefits include establishing positive routines and habits, friendships and connections as well as developing communication, problem-solving and creative skills. All children are entitled to access a preschool program over 4 terms the year before they start school.


Proportion of agree/strongly agree responses (%)


Proportion of agree/strongly agree responses (%)
